Submit copies of your COC, CEC, MEDICAL, BRM, letter of sobriety and verification from the employer that you have been fully familiarised along with documentary evidence from the vessels safety management system saved as individual PDF files named **"PEC\_DOCUMENT"** replacing **DOCUMENT** with either COC, CEC, MEDICAL, BTM. e.g. **"PEC\_COC"**

5. In the email please indicate your availability to sit the examination; PEC Examinations are conducted in Port Operations Center, Breakwater Road South, Dublin by appointment on the second Tuesday, Wednesday and Thursday of every month. Examinations are normally scheduled for 11:15 however other times can be scheduled with advanced notice.
